Paper Format. Consistency in the order, structure, and format of a paper allows readers to focus on a paper's content rather than its presentation. To format a paper in APA Style, writers can typically use the default settings and automatic formatting tools of their word-processing program or make only minor adjustments. The guidelines for paper format apply to both student assignments and manuscripts being submitted for publication to a journal.

Paper Format - APA Style
This article focuses on paper formatting. Throughout your paper, you need to apply the following APA format guidelines: Set page margins to 1 inch on all sides. Double-space all text, including headings. Indent the first line of every paragraph 0.5 inches. Use an accessible font (e.g., Times New Roman 12pt., Arial 11pt., or Georgia 11pt.).

General Rules of APA Format. Although your instructor may have other specific formatting requirements for you to follow, here are some general guidelines for how to write an APA paper. Use standard-sized paper (8.5 inches by 11 inches). Use a 1-inch margin on all sides. Type and double-space your paper.

How to Start Writing an APA-Style Paper
Requirements to the paper structure may differ but, typically, your essay should have 4 essential parts: APA essay title page, abstract, main body, and references list. The Title Page in APA format includes the title of the paper, the author's name, and the name of the institution. They should be centred on the page and double-spaced.

APA Format: Easy Explanations And Samples
APA papers often include an abstract, which is a short (150-250 words) summary of your essay, including brief descriptions of your topic, purpose, methodology, and/or findings. The point of an abstract is to inform potential readers of your essay's topic and purpose so that they can determine whether the essay is useful or relevant to their own research.

In APA format, a page with bibliography is called References. It can refer to the list of words cited throughout the paper, but most often it refers to the entire phrases of other authors.

In APA format papers, tables are generally used to describe the results of statistical analysis and other pertinent quantitative data. However, it is important to note that tables are not simply used to replicate data that has already been presented in the text of the paper and not all data should be presented in a table.

General APA Guidelines Your essay should be typed and double-spaced on standard-sized paper (8.5" x 11"), with 1" margins on all sides. You should use a clear font that is highly readable. APA recommends using 12 pt. Times New Roman font.
